

Policy AA-6 Currency of Practice (RN)

Rationale:

Healthcare is always evolving with new best practices, technologies, and methods. To ensure safe and effective care, registered nurses (RNs) need to stay up to date with their knowledge, skills, and judgment. At the College, we call this 'currency of practice'.

Purpose:

This policy outlines how applicants can meet the 'currency of practice' requirement for RN registration, renewal and reinstatement, to support holding a certificate of practice and engaging in practice.

Authority:

- Section 2.7(1)(d) of the College of Registered Nurses General Regulation identifies how an applicant can meet the currency of practice requirement for registration.
- Section 2.25(1)(e)(i) of the College of Registered Nurses General Regulation identifies the requirement to practice a minimum number of hours to renew a license.

Policy:

You can meet the currency of practice requirement in several ways, depending on which of the following is most recent:

Establishing Currency of Practice for Registration, Renewal and Reinstatement

Active RN Practice: Accumulate a minimum of 1125 practice hours in the last five
years or 450 hours in the last two years (as outlined in the Registration
Requirements Practice Direction). For details on what qualifies as practice hours,
refer to the Accepted Practice for Accruing Hours policy.

- 2. Competence assessment: within the last four years, you completed a Clinical Competence Assessment (CCA) and you did not require any remedial education. In cases where you needed remedial education, you have four years from the date of successfully completing your last course to meet the currency of practice requirement.
- 3. **Registered nurse entry-to-practice exam:** within the last **four** years, you passed the NCLEX-RN exam.
- 4. **Full Nurse Re-Entry Program (NREP):** you completed the full NREP program at Red River College Polytechnic within the last **two** years. If you have completed a CCA and were required to complete a course of instruction, please refer to option 2, above.

A Note on Renewals: If you are renewing your registration for the first time, you do not need to meet the practice hours requirement. Depending on the timing of your initial registration within the year, it may be difficult to accumulate the hours. You will have a full year to accumulate the required hours for subsequent renewals.

Other Ways to Establish Currency of Practice for Reinstatement

Reinstatement is the process by which former RNs – whose registration has lapsed – apply to return to active practice. Applicants for reinstatement can meet currency of practice in different ways, depending on how long ago you practiced as an RN in Manitoba, and how many practice hours you accrued.

^{*} You may submit a written request for an extension to complete your supervised practice hours and/or remedial education courses for scenarios 5(a), (b) and (c) above. The College will determine a reasonable deadline that balances any extenuating circumstances and the need for public safety.

^{**} If the applicant chooses to do a CCA (under scenario 5(d) above), they are committed to that pathway and must complete the courses identified as required by the College.
